IN THE MATTER OF ACCEPTING DEEDS  
FOR LAND TO BE USED FOR COUNTY  
ROAD PURPOSES FOR NORTH FORK  
SIUSLAW ROAD (COUNTY ROAD NO. 626)  
(18-11-08)

**WHEREAS**, the Board deeming it is in the best interest of Lane County to dedicate to the public the real property which was conveyed to Lane County by certain deeds, properly executed and granting such land for public road purposes; and

**WHEREAS**, the purpose of acquiring additional right of way in 1989-1990 was for a bridge reconstruction project as shown on a survey filed in Lane County Surveyor's Office, numbered County Survey File 31802 and the purpose of acquiring additional right of way in 2010 was for a road improvement project that relocated a portion of the road farther away from the river as shown on a survey filed in Lane County Surveyor's Office, numbered County Survey File 43987; and

**WHEREAS**, the Department of Public Works acquired certain deeds for real property for Lane County, properly executed on the dates set after the names of the Grantors, and before the recording information in the Lane County Deed Records, and the Board of County Commissioners of Lane County deeming it proper, as a convenience for property owners in the area and as a benefit to the general public, to accept the following deeds as county road as set forth below:
