POLICY: Traffic Safety in the Sheriff's Office has a primary mission of attempting to reduce injury and fatal traffic collisions on Lane County rural roadways through the enforcement of traffic laws.

RULE: None

PROCEDURE:

I. <u>Driving While Suspended (DWS)</u>

- A. DWS is either a traffic violation, a traffic crime (class A misdemeanor), or a felony (class C felony), depending upon the reason for suspension.
 - 1. DWS is a felony, if suspension is for:
 - a. Habitual traffic offender
 - b. Manslaughter or criminally negligent homicide resulting from operation of a motor vehicle
 - c. Commission of felony involving use of a motor vehicle
 - d. Hit-and-run involving physical injury
 - e. Reckless driving
 - f. Fleeing or attempting to elude
 - g. Driving under the influence of intoxicants (4th conviction)
 - 2. DWS is a traffic crime if suspension is for incidents such as "refuse to take breath tests," recklessly endangering, etc.
 - 3. DWS is a traffic violation if suspension is for "fail to furnish proof," etc. This should be a citation only. A custody report is not required.
 - 4. Dispatch will advise whether a driving suspension is a violation, misdemeanor, or felony. The information will be provided by DMV print out.

- B. A Uniform Traffic Citation and Complaint shall be issued in the case of a DWS violation, misdemeanor or felony, whether or not the person is taken into custody.
- C. The District Attorney's Office requires the following information on all DWS misdemeanor and felony reports:
 - 1. Did the person know about the suspension?
 - 2. If not, has the person moved from the address indicated on the driver's license, and when?
 - 3. If a move was made, was DMV notified?
 - 4. Whether or not the person had a license in possession and the indicated address. If the person was taken into custody, this information shall be indicated on the Custody Report. Otherwise, an Incident Report shall be filed.
 - 5. If a suspended driver is in possession of a driver's license, such license shall be confiscated, a receipt issued, and the license shall be submitted with the report, with instructions to return the license to DMV.
 - 6. If it is a felony or misdemeanor suspension, a PC Affidavit is required.
- II. Driving Under the Influence of Intoxicants (DUII)
 - A. DUII is a traffic crime (class A misdemeanor).
 - B. All DUII arrests shall include a Uniform Traffic Citation, a Custody Report, PC Affidavit, and a Drinking Driver Investigation Report.
 - C. Refer to G.O. 1.09 and 1.10 Alternatives to Incarceration.
